**1 WE DENOUNCE THE FURTHER OP-
PRESSION, PLUNDERING AND DEPEND-
ENCE OF THE COUNTRY BY IMPE-
RIALISM, MAINLY YANKEE IMPERI-
ALISM**

In application of the "Free Trade Agreement" (FTA) with the United States (U.S.), the fascist, genocidal and country-selling government of García-Gampietri continues the dispossession of the native populations and peasantry of our country of their territories and lands with all that is on top of them and in the subsoil, that is, the natural resources of the country to hand them over to big imperialist capital, mainly Yankee, and the big native bourgeoisie as intermediaries of imperialist capital.

75% of the Peruvian Amazon (55,000,000 hectares) has been earmarked by the government for oil plots. To which must be added those already in the hands of the imperialist monopolies and the big bourgeoisie and native landowners such as the Romero family, etc., destined for logging, oil palm production and other export products, as well as biofuels. In the Sierra, mining exploration and exploitation licenses have been granted to big capital, dispossessing private peasants and peasant communities of their lands and, on the Coast, these big imperialist companies or those of the landowners or of the big bourgeoisie such as the Romero, Rodríguez Banda, Brescia, Tam, etc., or of the big bourgeoisie of the country, or of the big bourgeoisie of Chilean, Colombian, bureaucratic capitalism, etc., have received all the new lands of all the big irrigations made by the State, to produce for the imperialist market or in different ways these same companies have taken away the lands owned by small peasants and agricultural cooperatives. We are witnessing further dispossession and a new process of great concentration of land, economic concentration and concentration of political power from the local (municipalities), regional and national level in the hands of large foreign and native monopolists.

2 WE DENOUNCE THAT THE GENOCIDE OF THE FREE TRADE AGREEMENT DOES NOT CEASE, THAT THE GOVERNMENT, AT THE BEHEST OF ITS IMPERIALIST MASTER, IS PREPARING GREATER, MORE COWARDLY AND MORE BLOODY GENOCIDES AGAINST THE MASSES

“The government that controls this State expropriates the nation to hand it over to big investment.”¹ In the face of the resistance of our people against this dispossession, in the face of their struggles, in the face of their strong protests, the country-selling García has called the peasants, our na-

tives, “dogs of the orchard” who are not capable, that is why we have to hand it over to the “big investment.”² Then, faced with the persistence of the struggle of the masses that does not cease, the García-Gampietri government, in order to comply with the FTA of greater surrender of the country to Yankee imperialism, sends, with the agreement of the Council of Ministers, the Army and the Police to machine-gun and commit all kinds of atrocities against the populations, as it has done in Bagua against the natives. This crime is the best known, but it is not only this fact, but many more, as in Piura, Ancash, Lima, Puno, Apurimac, Cuzco, Ayacucho.

Another example is that committed by the British mining company Monterrico Metals Plc, with its subsidiary Empresa Minera Majaz SA in the communities of Segundo and Cajas, and Yanta, without the consent of the local population, which is currently before a British court for the torture of dozens of peasants and the murder of a peasant during police and paramilitary repression against the peasant protest in 2005 against the Majaz mining project.

The murder, torture and sexual abuse suffered by the peasants was committed by a squad of special agents of the Peruvian police (DINOES) and private security agents of the company Forza Peru (bought in 2007 by the US Securitas corporation and whose agents are working in some cases as paramilitary groups to protect in Peru mining companies such as Newmont, Majaz–Rio Blanco Copper Co–and others). Forza Peru has links to the Peruvian armed forces and government, especially through Vice President Luis Giampietri). Forza acted at the request of Monterrico Metals Plc, with the support of a former British ambassador in Lima and a Peruvian security company, acting as a paramilitary group. With the strong support of the Peruvian government authorities, during the governments of Alejandro Toledo and Alan Garcia. Today the project continues with a Chinese social-imperialist company (Rio Blanco Copper SA). The peasantry continues its struggle against this social-imperialist mining company.

This same DINOES participated in the Bagua massacre, already mentioned, where dozens of peasants were killed after protesting against mining, oil and logging projects on their lands. DINOES is trained and financed in part by Yankee imperialism.

We denounce that these same forces of the DINOES with the Army and the Navy are threatening to commit a new act of genocide against the native

population and peasant settlers in Salvación, a town located in the jungle of Madre de Dios on the border with Brazil and Bolivia to protect the project of the Yankee company Hunt Oil and the Spanish company Repsol-YPF, a natural gas and oil exploration and extraction project in Block 76 granted by the country-selling government in the Communal Reserve and other lands of the native communities of the Yine, Matsigenka or Amarakaeri and Harakmbut.

3 WE DENOUNCE THE FACT THAT THIS GENOCIDE OF THE FTA WITH THE U.S. IS IMPLEMENTED AT THE SAME TIME AS THE GREATEST MILITARY INTERVENTION OF IMPERIALISM IN OUR COUNTRY DIRECTED BY THE U.S. SOUTHERN COMMAND

On the same day that the FTA went into effect, February 2, 2009, the Peruvian parliament approved the cession of Peruvian ports as bases for the U.S. Fourth Fleet, authorized the entry of U.S. Armed Forces personnel and weapons, etc. In the following months, new U.S. military bases were established in addition to the existing ones, forming a single system with the old and new U.S. military bases in Colombia, with the entry of U.S. officers, troops and mercenaries. Then a new VRAE Military Region is created and placed under the command of the Southern Command, which centralizes men and means from other military regions.

The presence of U.S. military is not a new issue in Peru, to disguise the facts, they present the U.S. military bases in Peru as Peruvian military or police facilities that are used for joint training in jungle fighting, for the operation of aircraft and U.S. technical intelligence or for the fight against drugs. Thus, in Peru there are 24 Yankee combat helicopters of the Huey type at the disposal of the U.S. DEA, 5 of them in the police base of Palmapampa in Ayacucho operated by Peruvians, the North Americans he says are only used for counter-narcotics operations and not in counter-insurgency operations, despite the fact that they are in the middle of the territorial area of the Main Regional Committee of the CPP. Gentlemen, this is unbelievable!

We denounce that Colombia and Peru serve as the axis of U.S. military intervention in the Andean region and in all of South America. By expanding the operational capacity of the U.S. military bases in Colombia, they manage as a single system those they are establishing in Peru. By the “scope of air mobility to the South American continent” available to the Southern Command, it is clear that these facilities will serve for operations in Peru, in the entire Andean region, in all of South America.³

The Yankees have planned, in their new Colombian bases, to further advance in the concentration of the functions of the former School of the Americas and other training sites, planning in the logic of extermination and military control of the United States for Latin American armies as it has been applying with the Armed Forces of Peru⁴

4 AS PART OF THIS INCREASED MILITARY INTERVENTION BY U.S. IMPERIALISM, THE GARCIA-GAMPIETRI GOVERNMENT HIRES THE SERVICES OF ISRAELI ADVISORS TO FURTHER DEVELOP THE “LOW INTENSITY WARFARE” DIRECTED BY THE U.S. SOUTHERN COMMAND

“The Israeli military team,” commanded by General B. Ziv, “will advise the Peruvian Army to confront narcoterrorism in the area of the Apurimac and Ene River Valley (VRAE), and for this work they will charge 12 million dollars,” we read in the newspaper “La primera” of Lima, November 1, 2009.

A retired military officer has warned that this consultancy could be an

attempt to establish “a beachhead” to “justify the presence of an electromagnetic interdiction base” as part of “the cybernetic commands that the North Americans are already installing in South America.” “Thus the North Americans, with the help of Israeli General B. Ziv, will no longer need to have a strong ground contingent, since this cybernetic base is enough to mobilize their airplanes from the bases in Colombia or, if necessary, the mercenary ‘Blackwater commandos’ for operations that will have nothing to do with the counter-subversive struggle.”⁵

“The Israelis will train the General Staff of the National Pacification Group, will carry out military training in the jungle, probably in the counter-subversive base of Mazamari, with patrols of the three armed institutes and will recommend the purchase of electronic intelligence and logistical instruments. The contract they have signed with the Ministry of Defense is for 12 million dollars.”⁶

That is to say, the “Israeli advisors” come to serve the hegemonic and counter-revolutionary plan of the Yankee master, they come to fight against the Communist Party of Peru, against the Maoist rebellion throughout the country that seeks to forge a powerful anti-imperialist movement in Peru, Latin America, and the world. They say it is for what they call the VRAE Region, a vast region of more than 380 square kilometers of territory and which includes several departments of the country.

The State of Israel has long fulfilled its role as an instrument of U.S. imperialism, also in Latin America and Peru. It is a triangulation to evade U.S. imperialism’s own domestic controls on arms sales, troop deployment and participation in covert operations abroad. And in the recent case of Peru, to disguise its intervention behind “consulting business by an Israeli businessman.” Therefore, we denounce the current U.S. intervention against our people as the new secret war of the genocidal Obama.

5 WE DENOUNCE THAT UNDER THE DIRECTION, ADVICE AND PARTICIPATION OF YANKEE OFFICERS, SOLDIERS, MERCENARIES, AND ISRAELI “ADVISORS,” THE GENOCIDAL ARMED FORCES OF PERU CONTINUE TO CARRY OUT GENOCIDE IN AN ATTEMPT TO ANNIHILATE THE PEOPLE’S WAR LED BY THE CPP

We denounce that under the direction, advice and participation of officers, soldiers and Yankee mercenaries and Israeli “advisors,” the genocidal Armed Forces of Peru continue to develop the genocide against our people in the Andes and the inter-Andean and jungle valleys, bombing and rocking the populations of the Support Bases and People’s Committees where the new construction is being built and the populations located in the Main Regional Committee of the CPP, with rockets, bombs from helicopters upgraded with new equipment brought by the Israelis, armored and with night visors and war cannons, they are planting landmines to cause the indiscriminate slaughter of the population. The genocidal Armed Forces and their Yankee masters want to inflict, in this way, the greatest number of casualties on the population to try to subjugate our people through reactionary terror and isolate the guerrillas from the masses and thus annihilate the people’s war of resistance against Yankee imperialism. That level of disgrace and crime like the one developed in “Operation Phoenix” in Vietnam by the Yankee Armed Forces is what they are currently applying in Peru, as psychological warfare which is part of their “low intensity warfare.”

6 WE DENOUNCE THAT THE REACTIONARY ARMED FORCES ARE VIOLATING ALL THE INTERNATIONAL TREATIES THEY HAVE SIGNED REGARDING THE USE OF ARMS AND PROTECTION OF THE POPULATION

We denounce that the Armed Forces of the old landlord-bureaucrat state at the service of Yankee imperialism are mainly committing these war crimes in violation of all the international treaties they have signed, such as the prohibition of anti-personnel mines, the use of weapons that endanger the civilian population, etc.

The newspaper *Correo de Ayacucho*, dated October 17, 2009, reported: “**WEAPONS.** According to confidential sources, in the fight against the narco-terrorist remnants in the well-known “green hell” (Vizcatán) in the Vrae, even war cannons are being used, a situation that is also prohibited.” On the 7th of the current month, in Ayacucho, there were press reports that after the action of the PLA against the military base in Vizcatán of the genocidal Armed Forces, these have “intensely rocked the zone for three hours” as a reprisal against the population after the guerrilla has caused them casualties (they recognize 1 dead and 3 wounded) causing civilian casualties with this criminal and indiscriminate attack, then they have accused the victims of being “terrorists” and arrested to cover up their criminal action and display false triumphs.

We denounce that the scandal of eavesdropping and electronic espionage such as the one carried out by Business Track owned by Manuel Ponce, a retired captain of the Peruvian Navy, friend and servant of Garcia-Gampietri,⁷ which operates with CIA equipment ceded to this military institution and operated by Navy officers and non-commissioned officers trained at Yankee military bases in Colombia) reveals that the CIA—through the Navy’s secret services and private companies set up by itself—continues its task begun with Fujimori-Montesinos of meddling, listening, recording, etc., everything of importance in search of “total control...” A master’s dream in search of controlling not only what his enemies or possible enemies do, but also what

his own lackeys do.

7 WE DENOUNCE THAT THE GREATEST AND MOST BLATANT IMPUNITY OF THE THOUSANDS UPON THOUSANDS OF CASES OF GENOCIDE COMMITTED BY THE CIVILIAN AND MILITARY AUTHORITIES

We denounce that the greatest and most blatant impunity of the thousands of thousands of cases of genocide committed by civilian and military authorities in the last 30 years in the country. That the civilian authorities and the genocidal Armed Forces feel encouraged in their sinister actions by the impunity guaranteed to them by the State itself, and its judicial institutions. The President and Vice-President of the country are incorrigible genocidaires, denounced in countless cases. The greatest genocides of the '90s, Fujimori and Montesinos, are enjoying protection, shelter and care in “penitentiary” facilities suitable for a life of comfort. Fujimori comes and goes as he pleases. In his comfortable offices he leads his parliamentary fraction, which is part of the parliamentary majority of García’s government.

No military chief has been convicted for war crimes and only one sergeant has been convicted for rape out of the thousands of cases of rape of women and children, the “trials” against the other genocides advance at a snail’s pace to ensure total impunity on the part of the old state, From that justice the people can expect nothing we have to blow it up along with all that old state. The following quote has the value of a confession: “If we take into account that at the level of the Public Prosecutor’s Office there are more than 1000 investigations, and that in the period 2003-2009 only 83 cases have been prosecuted, we have that the Peruvian State has only advanced 8 percent in its work of justice. Based on the results obtained, and applying the corresponding projection, it would take the State at least 75 more years to prosecute all the cases. In the same sense, if we consider that most of the human rights violations occurred 25 years ago, the temporary alternative of justice offered by the State demands a wait of 100 years from the victims,

their families, and society.”⁸

But the civilian and military genocidaires do not even want that, they are passing a series of laws of impunity for their war crimes, for their genocides, so that not even an investigation is initiated, so that nobody bothers them for their crimes. He says that any investigation has to go through a prior technical report evacuated by military or police elements. Likewise, the vice-president, the genocidal Gampietri, has proposed that the VRAE be declared a “war zone” in order to continue with more bombing and mass slaughter without having to be subjected to any investigation afterwards.

8 WE DENOUNCE THE NEW REACTIONARY HOAX OF THE ROL-CIA AGAINST THE HEAD OF THE CPP AND THE PERUVIAN REVOLUTION IN ORDER TO ANNIHILATE HIM

We denounce: that as part of this new and greater genocide against our people, the García-Gampietri government and the Yankee CIA have come out with a new hoax against the Head of the Communist Party of Peru and of the Peruvian revolution, Chairman Gonzalo, presenting an apocryphal book, entitled “De puño y letra, [In Handwriting–Trans.]” whose authorship they want to attribute to Chairman Gonzalo. In which it is claimed that he calls on the Party to participate in elections and clamors for amnesty. These rats of the ROL want to brutally repress the struggles of the masses in the municipalities and regional governments where they manage to participate. In this book of hoaxes, the real author, the traitorous rat Miriam, in her presentation says: “that he has already gone, that he is no longer Chairman Gonzalo. That is to say, in other words, that he is no longer useful.” Thus they prepare public opinion for the physical annihilation of Chairman Gonzalo. We condemn, crush and brand with fire the rats of the revisionist and capitulationist ROL that serve the plan of Yankee imperialism to impose its FTA with blood and fire and annihilate the people’s war in Peru, that leads
